3. On January 4, 2011 the Debtor filed a Motion for an Order Approving a Public Auction Sale of Property of the Estate Free and Clear of Liens And Encumbrances Pursuant to 11

U.S.C. §363(B) (the “Motion”), which this Court allowed on February 22, 2011. A copy of the order is attached hereto as Exhibit A.

4. On January 13, 2011 the Debtor filed an Application to Employ the Auctioneer (the “Application”) to sell the Silver at the public auction, which this Court granted on February 1, 2011. A copy of the order is attached hereto as Exhibit B.

5. On March 11, 2011, the Auctioneer conducted the public auction of the Silver.

6. The gross proceeds from the Auction are \$3,600.00. A report of the sale is annexed hereto as Exhibit C.

7. Pursuant to the terms of the Application, and MLBR 2016-1, the Auctioneer seeks compensation of \$360.00, as well as expenses related to the sale, in the amount of \$995.53. A statement of the Auctioneer’s expenses is attached hereto as Exhibit D.

8. Request is hereby made to limit notice regarding this Application upon the individuals and entities served with the Motion and Application, which are as follows: the U.S. Trustee, the Debtor, the top twenty unsecured creditors, the creditors committee, Gary Weiner, Esquire as counsel to the creditors committee, and all attorneys who have filed appearances in this case.

9. The Auctioneer submits that due to the nature of this Application for Compensation and Reimbursement, no further service is necessary.

WHEREFORE, Aaron Posnik & Company, Inc. respectfully prays:


1. That this Court authorize compensation in the amount of \$360.00, plus reimbursement in the amount of \$995.53 as an expense of the administration of this estate;


