Attorney Michele J. Feinstein to speak at Quinnipiac University School of Law symposium

Examining the advantages and disadvantages of giving beneficiaries the ability to opt out of court-supervised estate settlement, the program will feature the diverse perspectives of academics, judges and practitioners from both Connecticut and states that have adopted unsupervised probate.
